| Mandate | Process by which claimant group(s) identify representatives to engage with the Crown |
| Partial | Partial Settlement in lieu of final settlement |
| Comprehensive | Research of comprehensive historical claims by the claimant group includes everything pre 1992, wash up |
| Terms of Negotiation (ToN) | Agreement to the negotiation principals between the Crown and claimant group |
| Agreement in Principle (AIP) | Agreement to consider the proposed settlement package of the Crown. The intent where the settlement will end up |
| Deed of Settlement | Agreement by the Crown and the claimant group to the redress package |
| Settlement | Final Enactment of Settlement Legislation |
