# Treaty Settlement Process

<b>Mandate</b>	Process by which claimant group(s) identify representatives to engage with the Crown
<b>Partial</b>	Partial Settlement in lieu of final settlement
<b>Comprehensive</b>	Research of historical claims by the claimant group
<b>Terms of Negotiation (ToN)</b>	Agreement to the negotiation principals between the Crown and claimant group
<b>Agreement in Principle (AIP)</b>	Agreement to consider the proposed settlement package of the Crown
<b>Deed of Settlement (DoS)</b>	Agreement by the Crown and the claimant group to the redress package
<b>Legislation</b>	Settlement bill is considered by Parliament
<b>Settlement</b>	Final Enactment of Settlement Legislation
